Bid Form

The following materials obtained during the dismantling of old Haj House will be disposed off in public auction, in item wise and "AS IN WHERE IN BASIS" on **03.08.2017 at 16:00 Hrs.** The terms and conditions and details of items to be auctioned are given below.

Terms and Conditions:

1. The intending bidders have to deposit EMD of **Rs. 50,000/-** (Rupees Fifty thousand only) by way of Demand Draft in favor of "**Managing Director, JUIDCO Ltd.**" payable at **Ranchi** along the bid for participating in the auction. No interest will be payable on EMD.
2. After inspection of items, the bidder would quote item wise price of the scraped materials, which he is ready to pay for the scrap offered for sale in a sealed bid.
3. Bid should be signed by bidder(s) himself/themselves or a person duly authorized on his behalf. A copy of such authority should be enclosed along with the bid.
4. Bid forms are not transferable.
5. The EMD amount of all the non-successful bidders will be refunded with a condition that this amount is non-refundable for those successful auctioneers who fails to lift the bided items.
6. Bidder(s) can inspect the articles/items between 11.00 a.m. to 4.00 p.m. in the Haj House site, Kadru, Ranchi from **28.07.2017** to **01.08.2017**, in regard to the conditions, quality, etc. of the items and satisfy themselves before submitting their offer by the date and time specified.
7. Any tax/GST is livable shall be paid by the successful bidder.
8. All articles/items will be sold on Item wise "AS IS WHERE IS BASIS" and be deemed to have been on the clean understanding that they have satisfied themselves full in regard to the conditions, quality of the items proposed to be auctioned.
9. The successful bidder(s) will be required to make full payment of their quoted bid amount within **Three (3) days** by way of Demand Draft in favor of "**Managing Director, JUIDCO Ltd.**" payable at Ranchi by **17:00 Hrs.** on **06.08.2017** after the finalization of the bid.
10. The successful bidder will have to lift the items at his own cost, risk and arrangement by **17:00 Hrs.** by **09.08.2017** after depositing the full amount of payment of the bid otherwise the EMD will be forfeited.
11. The successful bidder will not be entitled to resell any of the articles/items while they are still lying within the site and no delivery would be effected by this Office to any person or person(s) other than the bidder whose name/names are mentioned in the Order.

12. The condemned items will be sold Item wise. The bidders shall quote the rate item wise as attached at **Annexure -A**. The bidder must fill item wise rate against the unit that should be equal to or more than minimum base price fixed for each items and submit the same by **03.08.2017, 15:00 Hrs.**
13. The bidder who would quote the highest price against each item shall be considered as successful bidder for such item/items.
14. The Bidder who would quote the highest rate for the scrap material shall be considered as the successful bidder for that item, the payment of the scrap steel shall be made by the bidder based on the actual weight to be meet by the weighing machine during the transportation from the Haj House site. Never the less, the bidder has to pay the cost of the scrap steel on the basis of the assessed weight (tons) jointly by the successful bidder and JUIDCO representative. The Balance amount if any, after weighing the actual scrap steel will be paid by the bidder or less if any, in weight of the scrap steel, the amount connected with it shall be refunded by JUIDCO.
15. Sealed Envelopes should contain the Bid Form, EMD, Price quotation and the cover should be superscribed as "Auction Notice for disposal of Scrap material of old Haj House Building" addressed to JUIDCO Ltd., 3rd Floor, Pragati Sadan, Near Kutchery Chowk, Ranchi and drop in person in the office on or before **03.08.2017 by 15:00 Hrs.**
- 16. All the weighing related charges for various scrap materials shall be borne by the successful bidders.**
17. The lifting of material will be in the presence of Four-member committee constituted by JUIDCO.
18. This office shall not be responsible for any delay.
19. The Bid form received without EMD amount will not be considered at all.
