

Subsequently M/s IK WORLDWIDE-SCP CONSULTANTS PTE LTD. CONSORTIUM had submitted the Land Acquisition Plan in April, 2018 and final DPR in Sep, 2018. The approval of the DPR has been communicated vide resolution no. 1140, dated-08.03.2019 of UD & HD, GoJ).
